5. Old Business- Beverly Botte

Pool Pump. The recirculating pump motor for the pool has locked up and caught fire internally. Taking the impeller and all the seals with it. It will cost \$5500.00 to \$6000.00 to replace depending on the work that needs to be done for the plumbing hook ups.

Green Space/retention area. Motorized vehicles are not allowed in the green spaces or retention areas. We have ordered signs to post at entrances of the green space.

6. New Business

Retention Area resolution proposal. Review proposed resolution.

Proposal for changing the deed restriction reporting in the Beacon. Presently we report 1st violations and complied by lot number. The proposal is to list the second and third violation notices by address, and list the number of 1st violations by category without identifying the lot or address. Noting the comments from our attorney advising against using addresses or names.

Proposal for changing the deed violation notice procedures. Review proposal.

Discuss using Article VI section 2 of the Declaration of Covenants, Conditions and Restrictions. This article discusses cleaning/repairing properties the Owner has failed to maintain and charging the Owner for the costs to complete the cleanup and repairs.

Discuss modifications of the retention area. Several areas are gopher tortoise habitat and protected. The resolution dated May 11, 2010 declares the "wooded areas as no admittance for humans and/or pets, including, but not limited to strolling, sitting, running, lounging, sleeping, jogging, camping or playing" ...

Proposal for movie night. In the August 9, 2022 meeting minutes it was announced that we would need to have a copyright license to show movies for a cost of \$2289.00 per year.

Hurricane cleanup. We are working on cleaning up all the trees in the retention area that have been damaged by the hurricanes. This is a slow process, please note that have identified and removed any trees that may cause harm to homeowner lots. If you have concerns about a specific area please contact the office.

Lock your car doors. The office has received a report of someone going through the community checking card doors overnight. Please make sure to lock your car doors and contact the Sherrif if you see anything.

Who to contact. Please contact code enforcement to report inoperable vehicles or expired tags. Contact the Sherrif's department for Trespassing issues, noise complaints or neighbor disputes. Contact WREC for streetlights that are not working. Contact the office for questions about deed restrictions, architectural forms or general community information.
